A Prayer for the New Year

Lord, we place ourselves in Your hands as another year begins may Your soft winds freshen our spirit, may Your sunshine brighten our hearts, may the burdens of the day rest lightly upon us and may we be enfolded in the mantle of Your love.

SOMETHING SPECIAL

Just lately something special seems to have been happening in our Church!

Firstly, Christmas, and the family celebration service was a really great experience, a feeling of joy, excitement and a real togetherness within the Church. You would expect this sort of feeling around Christmas time but somehow this year it was 'special'.

Then, on the second Sunday in January, our Minister, Rev David Wheeler took the service, which included sacrament (communion). As we started singing the last hymn, a real peace and joy filled the place. As the music played on at the end of the service every-one just sat on in their seats and took time to listen.

Our January Family Service was tinged with sadness for we had heard the news of Drs Mark and Sarah Human little son, recently born, and just diagnosed with a very rare genetic disorder. Sarah (nee Colwill) was a local girl and past member of our church and most sadly their first baby had died of the same problem about 18 months ago. Every-one felt so very sad for them, (and the rest of their family who live locally). The planned preacher was Eric Moore, a nurse at North Devon District Hospital. He was wonderfully sympathetic to this situation and as he conducted the service with a series of illustrations linked to Biblical sources, that same feeling of peace came into the place. Eric had asked the organist to choose the hymns and songs and it was amazing how these just seemed to fit in with Eric's sentiments. As prayers for friends who are sick and this little baby were said a sense of healing touched us. It was just something 'special'.

Just recently we've heard nationally that church attendances have gone down dramatically. Could this be because so often that 'something special' is missing from the traditional type of service? Could that something be God's own presence in the form of His Holy Spirit?

Worship should be a spiritual and meaningful experience and people everywhere are searching for such deep experiences, it seems, everywhere but in church. If you are searching, you will find a warm welcome to come and join us, for we all are seekers after the Truth.

CONTRACTS OF EMPLOYMENT

- Q. I've just got a seasonal job working in a fast food outlet. They've given me a contract to sign, which says there's no holiday pay, no sickness pay, no notice period. When I said it was unfair, I was told that if I was not happy then I could leave. What should I do?
- A. A contract of employment is an agreement between an employer and a worker setting out the terms under which they will have a working relationship. All employees, regardless of the number of hours they work, are entitled to a written statement of their main terms and conditions of employment within two months of starting work.
 - Generally, an employee and employer can agree whatever contractual terms they wish. However, a contract cannot take away a worker's statutory rights, which are given by law. So if, for example, a contract states a worker has no right to paid holiday, when by law virtually all workers are entitled to four weeks paid holiday a year, this clause in the contract is **void** and cannot be enforced. You will still be entitled to full time paid holiday even if you have signed the contract. Some terms are either imposed or implied in employment contracts by legislation. Other important statutory terms give workers the right to receive notice, receive the minimum wage and redundance pay, to return to work after maternity leave, not to be unfairly dismissed and not be discriminated against on the grounds of race or sex.

If an employer tries to insist on breaching a statutory right, an employee can refuse and claim unfair dismissal if they are sacked. You can do this irrespective of how long you have worked for the employer.

Employers may call the employees 'trainees' or 'casual workers' or 'self-employed' in the contract as a ploy to make it seem they have no employment rights.

You should get advice from your local CAB if you think your statutory rights are being breached.

Free Diabetes testing service

What is diabetes?

Diabetes Mellitus (often just called 'diabetes') is a condition in which the amount of glucose (sugar) in the blood is too high because the body is unable to use it properly. Glucose provides the body with energy and we obtain most from the digestion of starchy foods such as bread, rice and potatoes, from sugar and other sweet foods.

After eating, the level of glucose in the blood increases and the pancreas releases a hormone called insulin. Insulin regulates your glucose level to prevent is becoming too high or too low. If you have diabetes, the body either produces too little insulin, or resists its effects. The body then uses other sources of energy and unused glucose in the blood builds up, often causing thirst and frequent passing of water.

Recognise the Risks

Over 1.4 million people in the UK are diagnosed as having diabetes. However, it is suspected that there are at least another one million people who have the condition but are unaware of it.

Some people are at a higher risk than others. If you are Caucasion (white) aged over 40 or Asian/African-carribean aged over25 and any of the factors listed below apply to you, please speak to our Pharmacist. We may be able to help you reduce the likelihood of developing diabetes.

- You have a parent, brother or sister with diabetes
- · You are overweight
- You do not do much exercise
- You have given birth to a baby weighing more than 4kg(8lb8oz)
- Your blood glucose was high when you were pregnant

Different types of Diabetes

- Type 1 Usually affects people under 40 and occurs if the body is unable to produce any insulin.
 The symptoms are obvious and develop suddenly. This type of diabetes is treated with insulin injections, diet and physical activity.
- Type 2 Usually affects people aged over 40 but may develop at any age. The vast majority of people with diabetes have Type 2. The symptoms are usually less obvious and develop relatively slowly. Some people may not notice any symptoms at all for many years. This type of diabetes can often be treated very successfully with a healthy balanced diet and physical activity, or with the addition of tablets or insulin injections.

Search for the signs

The symptoms are common to both Type 1 and Type 2 diabetes but often develop more gradually and with less severity in people with Type 2. If you have one or more of these symptoms please speak to our pharmacist:

- You are always thirsty
- You always feel tired
- You do not do much exercise
- You often get cramps at night-time
- You often get infections
- You pass water excessively
- You sometimes suffer from blurred vision
- Your wounds heal slowly
- You often get thrush or genital itching
 Your hands and feet often feel numb

Complications associated with diabetes

Unfortunately, by the time that many people are diagnosed with diabetes they have already developed serious complications. Long term complications associated with diabetes include:

- High blood pressure
- Coronary heat disease and stroke
- High chloesterol
- Eye damage (and even blindness)
- Kidnev failure
- Nerve damage
- Leg ulcers



What is the CLS?

The Community Legal Service (CLS) makes it easier for you to get legal help and advice. It focuses on meeting the type of legal needs that most affect your lives.

These include:

Family & health problems

- Do I need a solicitor to get divorced?
- What will a divorce cost me?
- How do we make arrangements for our children if we get divorced?
- What do I do if my husband or wife is violent to me?
- What can I use mediation for?
- Who decides what sort of care I need?
- What rights do I have when I am in a residential or nursing home?
- What is the Mental Health Act for?
- Why should I make a will?

Money Problems

- What benefits am I entitled to?
- I'm getting into debt. What should I do?
- I can't pay my rent or mortgage?
- What is a County Court Judgement?

Housing problems

- I'm facing eviction. What now?
- Will the council find me somewhere to live?
- · What can I do if my landlord harasses me?

Work & employment problems

- Being treated unfairly at work?
- What is the minimum I should be paid?
- What can I do if I've been unfairly dismissed?

Will I have to pay?

Some CLS members offer free help and advice. Others charge for what they do.

You may be able to get help with the costs from the CLS fund (legal aid) It all depends on how much money you have and what kind of case it is.

Your solicitor or advisor will tell you whether you have a good case which might meet the tests for help, what sort of help you will need and whether you qualify for support to pay for it.

Information leaflets

The Consumers' Association has produced a series of free legal information leaflets for the Community Legal Service.

Subjects include debt, employment, divorce, renting, losing your home, welfare benefits, wills and probate, problems with goods and services, rights for people with disabilities, community care, mental health and family mediation.

Each of those people must surely be aware of the enormously expensive advertising campaigns funded by the Department of Health telling them how to avoid disease and disability by eating the right food.


