# **Milton Damerel Parish Council Minutes**

Of the Parish Council Meeting held on Wednesday 21<sup>st</sup> February 2018 commencing at 7.30pm. Present: Councillors Stephen Moyse (Chairman), Jim Richardson, Grace Millman, Rose Hayne,

Gareth Piper, John Webb and the Parish Clerk Lorraine Buttery.

Also present were County Councillor Barry Parsons and three members of the public

1) Apologies received from: P.C.S.O. Racquel Rowe, Councillor Richard Piper (Vice Chairman) - family commitment

### 2) Declarations of Interest

- a) Register of Interest: Councillors are reminded of the need to update their register of interests. None were declared
- b) To declare any personal interests in items on the agenda and their nature. None were declared
- c) To declare any disclosable pecuniary interests in items on the agenda and their nature. None were declared

### 3) Chairman's Announcements

Councillor Stephen Moyse announced that the bus shelter at Venn Green looked very smart and its erection would make a great deal of difference to those who use public transport, he sends his thanks to all those concerned who made it possible. The Clerk had sent an email of thanks to Julie Pepworth, with Councillor Barry Parsons copied in.

### 4) Public Comments, County and District Councillors reports

1) County Councillor Barry Parsons reported that the Council Tax for Torridge is likely to increase by 2.9% plus another 2 % to cover adult Care, this is equivalent to approximately 5% overall. On average this will equate to an increase of £1.22 a week for Band D properties. The good news is that the funds available for Community and locality grants have been increased with £10,000 being available for each., but please remember that I have 30 parishes to look after. If there are any projects that I can help with please let me know.

Councillor Parsons went to talk about the highways and that extra money has been allocated to Devon, but a bigger Proportion will be allocated to ditches to stop roads flooding. I will always fight your corner and help whenever I can. Councillors spoke about the very poor state of the roads in and around Milton Damerel, in particular the road leading out of Milton Damerel towards Holsworthy, this road is in dire need of repair, with pot holes trenches and in some places very poor surfaces which is a danger to all vehicles, and especially vulnerable cyclists and motor cyclists. Councillor Parsons requested that the Clerk email all details to him and during his meeting with highways he will make sure that they are aware of the complaints.

Councillor Parsons apologized that he had to leave right away as he had another meeting at Bridgerule.

The Chairman Councillor Stephen Moyse thanked Councillor Parsons for attending.

- 2) Three members of the Parish attended the meeting with the main topic of the conversation being the planning application at Town Farm. All Councillors and members of the public who had been contacted were bitterly disappointed that the public meeting which was to be held at 6pm was cancelled by Drews at 10.30am that morning. Questions asked of the Parish Council included:
- i) If residents had commented to Torridge planning on the original application would they have to re submit their comments for the new one?

Councillor Stephen Moyse said that he had phoned the case officer James Clemence and asked the same question, the reply was yes as it is a different application and the comments could not be transferred over. Councillor Moyse also mentioned the sewage problem and water run-off, he was told that all comments and complaints would be seriously considered.

- ii) Will the wall and finger posts be retained, and how will the original footpath be retained?
- ii) Why was the church not consulted?

Councillor Grace Millman commented that even though the deadline for comments might have passed the residents Should all still either write to Torridge or comment on their website, all comments will still be taken into account. Grace also spoke about the proposed new siting for the sewage plant, this would be positioned near an existing property, is this acceptable? Chairman Councillor Stephen Moyse said that it would be more appropriate to site it in a field. Other comments followed: the proposed main drain for the site comes down to the car park set aside for the affordable houses, is this appropriate?

There would also be a loss of privacy, loss of light for the existing property. The traffic increase is a worry. Councillor Jim Richardson asked is the development needed, as it is no longer a local need issue.

Resident commented that they had looked online at the transport analysis report and it was laughable, as it is

Resident commented that they had looked online at the transport analysis report and it was laughable, as it states That the extra traffic would be acceptable and did not take into account the narrow lanes and the danger to pedestrians walking to Venn Green to catch public transport.

The Chairman Councillor Stephen Moyse thanked the residents for their comments and the Parish Councillors would discuss the issue later in the meeting.

#### 2) 1/1067/2017/FULM

Proposal: Erection of sixteen dwellings and conversion of barn to 2 dwellings, creation of new vehicular accesses, new sewage treatment plant and associated landscaping - Affecting a Public Right of Way

Location: Land at Town Farm, Milton Damerel, Devon

Leading on from the discussions during the Public comments the Parish Councillors agreed that there were too many concerns and issues that had not been addressed by the developers and it was felt that the number of houses proposed were far too many, the site is in dire need of something being done as it is an eyesore.

Councillor Grace Millman stated that the Parish Council was very disappointed at not being able to give The Parishioners the opportunity to comment and ask questions of the developers at a Public Meeting. a vote was taken on the proposal: Does the Parish Council support the development?

The outcome was 5 against and one abstention.

The Parish Clerk will send the comments to Torridge planning, stating regrettably the application is not supported, with the previous Parish Councillors and residents comments being attached.
