### 2) Chairman's Announcements

Kit replied that at present no information was available and it is very frustrating, I believe no decisions have been made as everything could change. Councillor Moyse thanked Kit for attending and said he was very welcome to stay for the rest of the meeting if he so wished.

#### 9. Financial Matters

- a) Three Councillor signed cheques for:

- b) Financial report to date, all Councillors had a spreadsheet emailed to them and they raised no issues. The bank balance stands at £3982.83, being Ring Fenced, SBiT fund £183.02, DAAT fund £400, Balance of Defib. Grant the balance of £3041.24 being Parish General funds.

Buckpitt: the Clerk informed the Councillors that HSBC bank had supplied the wrong forms, the new ones were signed and the Clerk will take them into the bank in Holsworthy as instructed, she will let the new signatories know when they will have to go into the bank.

- 2) Councillor Gareth Piper apologised for not looking at the notice board, but will do so as soon as he is able.
- 3) A letter had been received from Isabel Fairbrother regarding a letter she had received regarding broadband in the area, and the erection of an areal on the Church Roof. Councillor Moyse said that this is really a matter for the Church to decide. The Clerk will write to Isabel. Councillor Hepple said that the lack of 'fibre optic' is an ongoing complaint and he would be willing to take it up on behalf of the Parish Council.
